Waiver of Claim for Damages and Consent to Locate Road

Board of County Commissioners et al.
 For a County Road to be known as the
Home Valley Cut-Off Road.

We, the undersigned, being the * owners of the property herein described, do, in consideration of the benefits and advantages to accrue to us by the location and establishment of the above proposed County Road, hereby consent that said road be established as described in the petition herein and as examined and surveyed, and forever relinquished to Skamania County, Washington, a Right-of-Way 60 ± feet in width over and across the following described piece or parcel of land, to-wit: Thirty feet on each side of the center line as staked on the ground and shown by plat on file in Office of Skamania County Engineer. Except the County may use an additional width where required for cuts and fills as shown on plat. This right of way being across that portion of Section 26 Township 3 North, Range 8 E. W. M. owned by the grantor's as recorded in Book 32 of Deeds, Page 575 in the County Auditor's Office. By the granting of this Waiver, Skamania County relinquishes all claims to the Right of Way given by Andrew Frost across the tract above described as recorded Page 512 in Book One of Waivers, Office of County Engineer. The County further agrees to purchase and deliver to the grantors at their residence, 400 steel posts 7 ft. in length and enough barbed wire to place a four wire fence on both sides of the Right of Way of above named road. The granting of this Waiver does not give the County the right to borrow road material outside the limits of the Right of Way as shown on plat of said road. The agreements stated on this waiver are full payment for Right of Way hereby granted.

and waive all claims for damages of whatever kind which may be occasioned to said land or any portion of the same by examining, surveying, laying out and establishing said Road.

Giving and granting unto said Skamania County, Washington, the said Right-of-Way, with full power and authority to examine, survey, lay out and establish said Road as proposed, and to peacefully maintain the same as a County Road.
