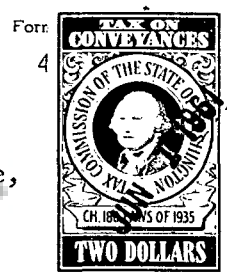

husband and wife,

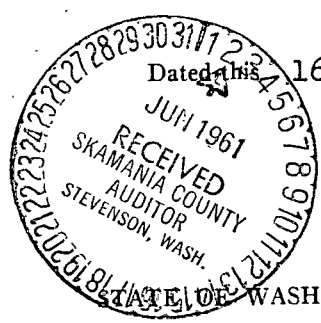
the following described real estate, situated in the County of Skamania, State of Washington:

A tract of land located in the Southwest Quarter of the Southeast Quarter (SW¹/₄ SE¹/₄) of Section 1, Township 1 North, Range 5 E. W. M., more particularly described as follows: Beginning at a point 3,042.9 feet east and 293 feet north of the southwest corner of the said Section 1; thence north 234.3 feet to the southerly boundary of Primary State Highway No. 8; thence along the southerly boundary of said highway north 57° 20' east 417 feet; thence south 297.7 feet to the northerly boundary of the Spokane, Portland, & Seattle Railway Company's right of way; thence south 65° 16' west along the northerly boundary of said right of way 386.4 feet to the point of beginning; said tract containing 2.15 acres, more or less; EXCEPT a strip of land 0.17 acres, more or less, along the west side thereof conveyed to Hazel Barks Gibson by deed dated June 2, 1933, and recorded May 16, 1945, at page 360 of Book 30 of Deeds, Records of Skamania County, Washington;
