It appearing to the Commissioner of Public Lands at this time that Application No. 2383 was filed in this office by the United States of America, Gifford Pinchot National Forest, for an easement for a right of way for a road over the NE½ NE½, SW½ NE½ and E½ SW½, Section 18, Township 7 North, Range 6 East, W.M., in Skamania County; that said application was filed in accordance with the provisions of Chapter 145, Session Laws of 1945, providing for the granting of rights of way to the United States Government over State lands; and

It further appearing that a right of way 66 feet in width is desired; that there are no improvements or merchantable timber on the right of way; that no good reason exists why this easement for right of way should not be granted; and the Commissioner being fully advised, it is therefore

of way as filed with said Application No. 2383 be and the same is hereby approved as the official plat of said road; and that an easement for right of way be and the same is hereby granted to the United States of America for a road over the following described lands:

Those portions of the NEX NEX, SWX NEX and Ex SWX, Section 18 SKAM RECEIVED Township 7 North, Range 6 East, W.M., included within the limits of SHEVENSON, WAS a strip of land 66 feet in width and having 33 feet of such width on each side of the following described centerlines:

Beginning at a point on the South line of said Section 18, which is N 89° 54' W 940.7 feet from the south quarter section corner thereof and running thence N 38° E 62.3 feet, thence on a 10° curve to the right 225.0 feet, thence N 60° 30' E 461.0 feet, thence on a 20° curve to the left 232.5 feet, thence N 14° E 129.5 feet, thence on a 20° curve to the left 105.0 feet, thence N 7° W 176.0 feet, thence on a 15° curve to the right 100.0 feet, thence N 8° E 650.0 feet, thence on a 14° curve to the right 242.9 feet, thence N 42° E 873.1 feet, thence on a 24° curve to the right 102.1 feet, thence N 66° 30' E 255.9 feet, thence on a 32° curve to the left 102.3 feet and thence N 33° 15' E 2,810.1 feet to a point on the east line of said Section 18 which is S 0° 05' E 82.0 feet from the northeast corner thereof and having an area of 6.60 acres as shown on the plat thereof on file in the office of the Commissioner of Public Lands at Olympia, Washington.

Subject, however, to an easement for a right of way for a logging road granted to International Paper Company by Right of Way Certificate No. 26339 issued for a term of 10 years from February 1, 1960 under Application No. 26339.
