in consideration of \$1.00 and other valuable consideration, hereby consent and agree that the lien of said mortgage shall be subordinate and subject to a perpetual easement grounded or to be granted by the owner or owners of the land referred to herein to the UNITED STATES OF AMERICA, for the purpose of constructing, operating, and maintaining one or more electric transmission lines over, upon, and across the following-described land in the County of Skamania, to-wit:

That portion of a strip of land 162.5 feet in width which lies within the following:

Government Lot 6 and the SASE, of section 3, Township 2 North, Range 7 East, Willamette Meridien, Skamania County, Assington, lying northwesterly of the existing 300-foot right-of-way of the Bonneville Power Administration Bonneville-Coulee Nos. 1 and 2 transmission lines.

Said strip of land lies on the northwesterly side of, runs prallel with and adjoins the existing 100-foot right-of-way of the Bonneville Power Administration's Stevenson Tap to Bonneville-Alcoa Mos. 1 and 2 transmission lines, the survey line of said 100-foot right-of-way being described in that certain easement deed dated February 27, 1965, recorded in Volume 51, page 150, File No. 61230, Deed records of said County.

Also, danger trees edjacent to Tractim-0-600 shown in greed on whibit attached hereto and by this reference and a court hereof.

Said perpetual easement is being conveyed to the United States of America by J. Aussell Sh Virginia ri. Sherman, husband and wife, in accordance with the terms of an option contract dated December 25, 1970.

The undersigned hereby waive——the priority of said mortgage in favor of said perpetual easement to the same extent as if an easement deed had been executed, delivered, and recorded prior to the mortgage hereinabove discribed, and agree that in the event of foreclosure of said mortgage the premises shall be said subject to the aforementioned easement.

Except as herein specifically subordinated, all property described in said martgage is to remain subject thereto.

This agreement shall be binding on the heirs, administrators or assigns at the holder of said miritage and shall mure to the benefit of the UNITED STATES OF AMERICA and its assigns.
