The Mortgagor, hereby (jointly and severally if more than one) covenant and agree with the Mortgagee as follows:

That the Mortgagers have a valid, unincumbered title in fee simple to said premises, and will werrant and forever defend the same against the tuwful claims and demands of all person whomsoever.

That the Morty yors will during the continuance of this mortgage, permit no waste or strip of the mortgaged premises and will keep the Addings and appurtenances on said property in good state of repair.

That the Mortgagors will nay said promissory note according to its terms. Should the Mortgagors fail to pay any installment of paincipal or interest provided for in said note, or any sum due under this mortgage, or breach of any covenant or agreement herein contained, then the entire debt secured by this mortgage shall, at the election of the Mortgages, become immediately due and payable. Should the Mortgagors fail to pay any sum which they are required to pay, the Mortgages may, without waiver of any 1720-04 nervoinder for such breach, make full or partial payment thereof, and the amount so paid with interest thereon at 10%, per annum shall become immediately payable to the Mortgage and shall be secured by this mortgage. Any payments made by the Mortgagors upon the indebtedness secured by this mortgage may be applied as the Mortgage may elect either upon the amount which may be due upon said promissory note or upon any amount which may be due under the provisions of this mortgage.

That the Mortgagor, will keep all buildings thereon continuously insured against loss or damage by fire and such other hazards as the Mortgagor may specify to the extent of the amount due hercunder, in some responsible insurance company or companies and stately to the Mortgagors and for the protection of the latter, and that the Mortgagors will cause all insurance policies to be initially endorsed and delivered to the Mortgagore, together with receipts showing payment of all promiums due therefor, and that the Mortgagors will keep no insurance on said building other than as stated herein. That it shall be optional with the Mortgagors to a time the company or companies and the agents thereof by which the insurance shall be written, and to refuse acceptance of any policy offered, and to surrender and cause to be cancelled any policy which may be received or accepted, and to place the incurance or cause the policies to be written, all at the cost, charge and expense of the Mortgagors; but in no event shall the Mortgagoe be held responsible for failure to have any insurance written or for any loss or damage growing out of a defect in any holicy, at growing out of the failure of any insurance company to pay for any loss or damage insured against. That the Mortgagoe is authorized to compromise and settle any claims for insurance, and to receipt therefor on behalf both of the Mortgagors and their assigns and the Mortgagoe.

That the Mortgagen will pay all taxes, assessments, and other governmental levies, now or hereafter assessed against the mortgaged premises, or imposed upon this mortgage or the note secured hereby, as soon as the same become due and payable, and shall immediately pay and discharge any lien having precedence over this mortgage. And to assure prompt payment the Mortgages agree to pay to the Mortgages any lien having precedence over this mortgages. And such budget payments are hereby pledged to the Mortgagee as collateral security for full performance of this mortgage, and the note secured hereby and the Mortgagee may, at any time, without notice, apply said budget payments upon any sums delinquent upon said note or under the terms of this mortgage. mortgage.

In any action brought to foreclose this mortgage or to protect the lien hereof, the Mortgagee shall be entitled to recover from the Mortgages a reasonable attorney fee to be allowed by the court, and the reasonable cost of searching the records and obtaining abstracts of title or title reports for use in said action, and said sums shall be secured by this mortgage. In such foreclosure action a deficiency judgment may be entered in favor of the Mortgagee, and a receiver may be appointed at the Mortgagee's request to collect the rents, issues and profits from the mortgaged premises.

And it is further covenanted and agreed that the owner and holder of this mortgage and of the promissory note secured hereby shall have the right, without notice, to grant to any person liable for said mortgage indebtedness, any extension of time for payment of all or any part thereof, without in any way affecting the personal liability of any party obligated to pay such indebtedness.
