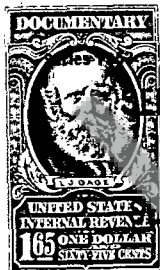
for and in consideration of Ten Dollars and other valuable considerations,

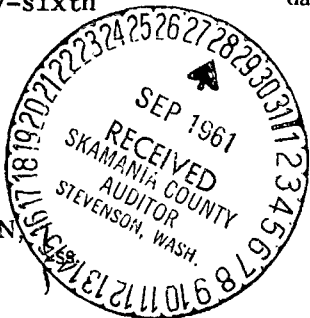
