KNOW ALL MEN BY THESE PRESENTS, That Donald Kay David, a single man, being over the age of twenty-one (21) years, and Erma Jane Schneider, formerly Erma Jane David, being over the age of twenty-one (21) years, both of whom were and are the sole surviving lineal descendants of Kenneth L. David, who died on October 16, 1946, at Portland, Oregon, and George A. Schneider, husband of Erma Jane Schneider, grantors, in consideration of Ten (\$10.00) and 00/100 Dollars and other valuable considerations to them paid by Beulah L. David, unmarried widow of said Kenneth L. David, grantee, do hereby grant, bargain, sell and convey unto the said grantee, her heirs and assigns all the following real property, together with the tenements, hereditaments and appurtenances situated in the County of Skamania and State of Washington, bounded and described as follows, to-wit:
