

WARRANTY DEED

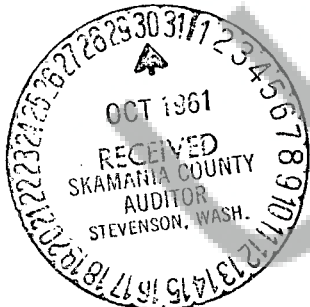

The Northeast Quarter of the Southeast Quarter of the Northeast Quarter (NE $\frac{1}{4}$ SE $\frac{1}{4}$ NE $\frac{1}{4}$) of Section 1, Township 3 North, Range 7 $\frac{1}{2}$ E. W. M. EXCEPT that portion thereof lying northerly and easterly of the center of the Wind River Highway;

ALSO: A tract of land located in Government Lots 4 and 5 of Section 6, Township 3 North, Range 8 E. W. M. more particularly described as follows:
