## MORTGAGE

The budget payments so accumulated may be applied by the Mortgages to the payment of such taxes, assessments, or levies, in the sincunts shown by the official statements thereof, and to the payment insurance premiums in the amount actually paid or incurred therefor. And such budget payments are nereby pleaged to the mortgage as collateral security for full performance of this mortgage and the note secured hereby and the Mortgages may, any time, without notice, apply said budget payments upon any sums delinquent upon said note or under the terms of the mortgage.

In any action brought to foreclose this mortgage or to protect the lien hereof, the Mortgages shall be entitled to recover from the Mortgagers a reasonable attorney fee to be allowed by the court, and the reasonable cost of searching the records and obtaining abstracts of title or title reports for use in said action, and said sums shall be secured by this mortgage. In such foreclosure action a deficiency judgment may be entered in favor of the Mortgagee, and a receiver may be appointed at the Mortgagee's request to collect the rents, issues and profits from the mortgaged premises.

And it is further covenanted and agreed that the owner and holder of this mortgage and of the promissory note secured hereby shall have the right, without notice, to grant to any person liable for said mortgage indebtedness, any extension of that for payment of all or any part thereof, without in any way affecting the personal liability of any party obligated to pay such indebtedness.

Wherever the terms "mortgagors" occur herein it shall mean "mortgagor" when only one person executed this document, and the liability hereunder shall be joint and several.
