RIGHT OF WAY DEED

KNOW ALL MEN BY THESE PRESENTS, that William J. Wineberg and Janet R. Wineberg, husband and wife; and J. A. Robbins and Anna M. Robbins, husband and wife, hereinafter called the "Grantor," party of the first part, and the United States of America, party of the second part, WITNESSETH:

That for and in consideration of \$850.00, the Grantor does hereby bargain, sell and convey unto the United States and its assigns an easement and all timber thereon and right of way for a road to be located, constructed, reconstructed, operated, patrolled, repaired, and maintained under the authority of the Secretary of Agriculture of the United States, hereinafter called the "Government," and known as the Green River Road, Project Number 1203.2, over, upon, along and across the following described premises 45 situated in the County of Skamania, State of Washington, to-with the county of Skamania, State of W

A strip of land 66 feet in width traversing the following described real property:

Germania Secundus No. 2 lode and Adamantine No. 2 Tode ras 500 located within NW2 and W2 NE2 Section 17, Township 10 North, Mask Range 6 East, Willamette Meridian.

The said strip being 33 feet in width on each side of a center line as located and to be constructed on the ground, with as much additional width as required for adequate protection of cuts and fills, the said center line being located and described as shown on Exhibit A which is attached hereto and made a part hereof.

The parcel of the Grantor's property to which this description applies contains two acres, more or less.

The exact location of the road upon construction is hereby deemed accepted by the Grantor.

Together with such reasonable rights of occupancy on the Grantor's lands immediately adjacent to said right of way as may be necessary for the construction, maintenance and repair of said road.

The rights, privileges and authorities herein granted are for full use and enjoyment by the Government for any and all purposes deemed necessary or desirable in connection with the control, management and administration of the national forest or the resources thereof, and, insofar as compatible therewith, use by the general public and the rights, privileges and authorities herein granted shall continue as long as used for the purposes

granted, but if for a period of five years the Government shall cease to use the rights, privileges and authorities for the purposes granted or shall abandon the use of the easement herein granted, then, in any such events, the premises traversed thereby shall be freed from said easement as fully and completely as if this indenture had not been made.
