

Easement Deed No. 26074-W

NORTHERN PACIFIC RAILWAY

The grantor NORTHERN PACIFIC RAILWAY COMPANY, a Wisconsin corporation, in consideration of the sum of one dollar (\$1), and other valuable consideration, in hand paid, receipt thereof is hereby acknowledged, does hereby grant unto the STATE OF WASHINGTON, DEPARTMENT OF NATURAL RESOURCES, grantee, its successors and assigns, a perpetual non-exclusive easement for a road right of way over and across the following described tract of land in Skamania County, State of Washington, to-wit:

A strip of land 60 feet wide being 30 feet in width on each side of the survey line for said road as the same is now surveyed and located over and across the southwest quarter of southwest quarter $(SW_{\frac{1}{4}} \circ fSW_{\frac{1}{4}})$ of Section nine (9), in Township seven (7) North, Range six (6) East of the Willamette Meridian. The survey line for said road is more particularly described as follows:

The rights herein granted are subject to the following terms and conditions:

1. The right of way herein granted is for the sole purpose of constructing and/or maintaining a road to provide access to and from lands presently owned or hereafter acquired by the grantee, or controlled by the grantee, for land management and administration activities. Land management and administration activities shall be defined as police protection, fire presuppression and suppression, inspection, cruising, thinning, stand improvement, inventorying, surveying, acquisition and disposal of land, timber and other valuable resources, eradication of forest insects, pest and disease, log removal operations, and other activities of a similar nature.

2. The grantor reserves to itself, its successors and assigns, the right to use the roadway in any manner which does not unreasonably interfere with the use of said road by the grantee, its assigns, successors, agents, contractors, employees, or licensees. Said road users will, however, contribute their pro rata share to the maintenance costs caused by their usage so that such maintenance will leave the road in as good a condition as existed at the time of commencement of said use.
