80/100- - - - - (\$4,281.80) - - - - - Dollars.

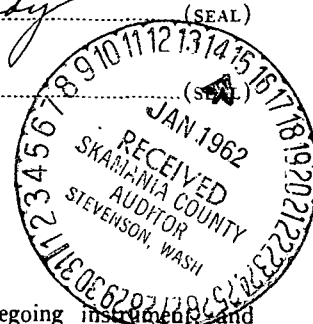
