and to place, construct, operate, repair, maintain, and replace thereon and in or upon all streets, roads or high-
ways abutting said lands an electric transmission or distribution line or system, it being understood and agreed constructed
that said transmission and-or distribution line shall be located approximately as the same is now surveyed and
staked upon said ground, and to consist of approximately pole lo-
cations and anchor locations, and to cut and trim trees, brush and grasses to the extent necessary to
keep them clear of said electric line or system and to cut down from time to time all dead, weak, leaning or dan-
gerous trees or brush that are tall enough to strike the wires in falling, or that might be or become a fire hazard,
and to remove all brush and grasses near the poles that might become a fire hazard,

In granting this easement it is understood that at pole locations only a single pole and appurtenances will be used, and that the location of the poles will be such as to form the least possible interference to farm operations, so long as it does not materially increase the cost of construction.
