

WARRANTY DEED

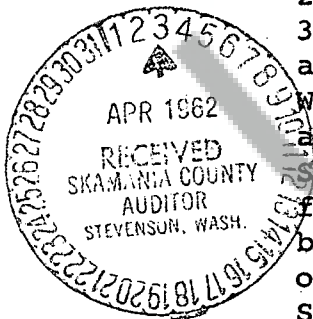
THE GRANTOR, BERNIECE SHORES, a single woman, for and in consideration of the sum of ONE THOUSAND ONE HUNDRED DOLLARS (\$1,100.00), the receipt whereof is hereby acknowledged, does hereby convey and warrant unto STANLEY K. KELLY, a single man, the Grantee, the following described real property situated in Skamania County, State of Washington, to-wit:

Lots 3, 4 and 5 of Block 2 of North Bonneville, Skamania County, Washington, according to the unrecorded plat thereof, more particularly described as follows:

LOT 3: Beginning at a point on the Southern line of the Evergreen Highway which said point is South 81°00' East 300 feet from a point which is South 1257 feet and West 38.9 feet from the common corner of Sections 15, 16, 21 and 22 in Township 2 North of Range 7, East of the Willamette Meridian and running thence South 81°00' East along the Southerly line of said highway, 50 feet; thence South 9°00' West 100 feet; thence North 81°00' West 50 feet; and thence North 9°00' East 100 feet to the place of beginning, said tract being designated as Lot 3 in Block 2 of the unrecorded plat of North Bonneville, Skamania County, Washington.

LOT 4: Beginning at a point on the Southerly line of the Evergreen Highway which said point is South 81°00' East 250 feet from a point which is South 1257 feet and West 38.93 feet from the common corner of Sections 15, 16, 21 and 22, in Township 2, North of Range 7, East of the Willamette Meridian and running thence South 81°00' East along the Southerly line of said highway 50 feet; thence South 9°00' West 100 feet; thence North 81°00' West 50 feet; thence North 9°00' East 100 feet to the place of beginning, said tract being designated as Lot 4, Block 2 of the unrecorded plat of the Town of North Bonneville, Skamania County, Washington.

LOT 5: Beginning at a point on the Southerly line of the Evergreen Highway which is South 81°00' East 200 feet from a point which is South 1257 feet and West 38.93 feet from the common corner of Sections 15, 16, 21 and 22 in Township 2 North of Range 7, East of the Willamette Meridian, and running thence South 81°00' East along said highway 50 feet; thence South 9°00' West 100 feet; thence North 81°00' West 50 feet; and thence North 9°00' East 100 feet to the place of beginning, said tract being designated as Lot 5 in Block 2 of the unrecorded plat of
