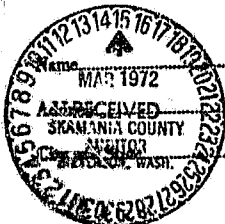

situated in the County of Skamania State of Washington:—

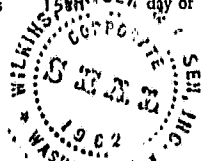
That portion of the Southeast Quarter (SE $\frac{1}{4}$) of Section 17, Township 3 North, Range 8
E. W. M., more particularly described as follows:

Beginning at the southeast corner of the said Section 17; thence south 89° 15' west
along the south line of the said Section 17 a distance of 514 feet to the initial
point of the tract hereby described; thence north 716.8 feet; thence south 89° 15'
west parallel to the south line of the said Section 17 to intersection with the
easterly line of the 150 foot right of way conveyed to the State of Washington for
Secondary State Highway No. 8-C by deed dated October 9, 1956, and recorded at page
430 of Book 42 of Deeds, Records of Skamania County, Washington; thence in a south-
erly direction following the easterly line of said right of way to intersection with
the south line of the said Section 17; thence east to the initial point.

And the mortgagor promises and agrees to pay before delinquency all taxes, special assessments and other public

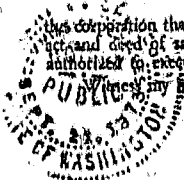
