Township 3 North, Range 8 E. W. M., lying southerly of the right of way acquired by the
State of Washington for Primary State Highway No. 8;

EXCEPT a tract of land conveyed to W. R. Nunn described as follows: Beginning at the
intersection of the east line of the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 29, Township 3 North,
Range 8 E. W. M. with the south line of State Highway No. 8 (also known as U. S. High-
way 830); thence south 340 feet; thence in a southwesterly direction 275 feet to a
point 340 feet due south of the south line of said highway; thence north 340 feet to

for the benefit of the mortgagee and to deliver all policies and renewals to the mortgagee.

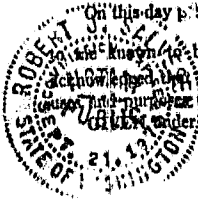
In case the mortgagor shall fail to pay any installment of principal or interest secured hereby when due or
