, State of Washington, mortgagor, and Skamania the Administrator of Veterans Affairs, an Officer of the United States of America, whose principal office , County of and post office address is Veterans Administration, Washington 25, D.C., and his successors in office, as such, and assigns, mortgagee,

WITNESSETH, That the mortgager mortgages to the mortgagee, his successors in office and assigns, the following-described property, situated in the County of and State of Washington, to wit:

> Lot 10 of WELL'S HOME SITES according to the official plat thereof on file and of record at page 102 of Book A of Plats Records of Skamania County, Washington.

The within-described mortgaged propert, is not used principally for agricultural or farming purposes, Together with all tenements and hereditaments belonging or appertaining thereto, and all rents, issues and profits thereof (provided, however, that the mortgagor shall be entitled to collect and retain the said rents, issuen and profits until default bereunder), and all fixtures now or hereafter attached to or used in connection with the premises herein described; and in addition thereto the following described household appliances, which are and shall be deemed to be, fixtures and a part of the realty, and are a portion of the security for the indebtedness herein mentione is

together with all interest therein of the mortgagor and that which is hereafter acquired by him.

To secure the payment of the principal sum of Fourteen Thousand Two Hundred Fifty & no/100 Dollars (\$ 14,250.00), as evidenced by a certain promissory note of even date herewith and the terms of which are incorporated herein by reference with interest from date at the rate of per centum (7 %) per annum on the balance remaining from time to time unpaid; the said principal and interest to be payable at the office of the Loan Guaranty Officer, Veterans Administration Regional Office in Seattle, Washington, or at such other place as the holder may designate in writing delivered or

mailed to the mortgagor, in monthly instalments of the fluid ed and 72 110 and day of May 19 72 and continuing on the last day of edge of the fluid ed and 72 110 and day of edge of the fluid e day of May , 19 72 , and continuing on the 1st day of each month thereafter until the principal and interest are fully paid, except that, if not sooner paid, the final payment of the entire indebtedness evidenced by said note, shall be due and payable on the day of April , 19 3/.

And the mortgagor does hereby towenant that he is lawfully seized of an indefeasible estate in fee (or such other estate, if any, as is stated herein); that said premises are free of any encumbrances except as herein otherwise recited; that he hereby warrants the usual covenants to the same extent as a statutory warranty deed under the laws of the State of Washington and all covenants herein nade, and that he will defend against any breach of any or all of the same.

The mortgagor further covenants and agrees as follows:

- 1. That he will pay the indebtedness, as her indefere provided. Privilege is reserved to prepay at any time, without premium or fee, the entire indebtedness or any part thereof not less than the amount of one installment, or one hundred dollars (\$100,00), whichever is less. Any prepayment made on other than an installment due date will not be credited until the next following installment due date.
- 2. In order more fully to protect the security of this mortgage, the mortgagor, together with, and in addition to, the monthly installments of principal and interest payable under the terms of the note secured hereby, on the installment due day of each month until the said note is fully paid, will pay to
 - (a) A sum equal to the ground rents, if any, next due, plus the premiums that will next become due and payable on policies of fire and other hazard insurance covering the mortgaged property, plus taxes and assessments next due on the mortgaged property (all as estimated by the mortgagec, and of which the mortgagor is notified) less all sums already paid therefor divided by the number of months to clapse before one month prior to the date when such ground rents, premiums, taxes and assessments will become delinquent, such sums to be held by mortgagee in trust to pay said ground rents, premiums, taxes and special assessments.
 - (b) The aggregate of the amounts payable pursuant to subparagraph (a) and those payable on the note secured hereby, shall be paid in a single payment each month, to be applied to the following items in the order stated:
 - I. Ground rents, taxes, assessments, fire and other hazard insurance premiums;
 - II. interest on the note secured hereby; and
 - III. amortization of the principal of said note.

Any deficiency in the amount of any such aggregate monthly payments shall, unless made good by the mortgagor prior to the due date of the next such payment, constitute an event of default under this mortgage. At mortgagee's option, mortgager will pay a "late charge" not exceeding four per centum (4%) of any installment when paid more than lifteen (15) days after the due date thereof to cover the extra expense involved in handling delinquent payments, but such "late charge" shall not be payable out of the proceeds of any sale made to satisfy the indebtedness secured hereby, unless such proceeds are sufficient to discharge the entire indebtedness and all proper costs and

- 3. If the total of the payments made by the mortgagor until (a) of paragraph 2 receding shall exceed the amount of payments actually made by the mortgage for ground rent, taxes or accessments or incurance premiums, as the case may be, such excess shall be credited on subsequent payments to be made by the mortgagor for such items or, at nortgage's option, shall be refunded to mortgagor. If, however, such monthly payments shall not be similarly flictent to pay such items when the same shall become due and payable, then the mortgagor shall pay to the mortgage any amount necessary to make up the deficiency, which notice may be given by mail. If at any time the mortgagor shall tender to the mortgage, in accordance with the provisions of the note secured hereby, the mortgage shall, in to the account of the mortgagor any credit balance remaining under the provisions of (a) of paragraph 2 hereof. If there shall be a default under any of the provisions of this mortgage resulting its a public sale of the premises covered hereby, or if the mortgage acquires the property otherwise after default, the mortgagee shall apply, at the time of the commencement of such proceedings, or at the time the property is otherwise acquired, the amount then remaining to credit of mortgagor under (a) of paragraph 2 preceding as a credit on the interest accorded and unpaid and the balance to the principal then remaining unpaid on said note.
- 4. That the lien of this instrument shall remain in full force and effect during any postponement or extension of the time of payment of the indebtedness or any pare thereof secured hereby.
- 5. He will pay all taxes, assessments, water rates, and other governmental or municipal charges, fines, or impositions, except when payment for all such items has therefore been made under (a) of paragraph 2 hereof, and will promptly deliver the official receipts therefor to the said mortgagee; and in default thereof the mortgagee may pay the same.
- 6. He will keep all buildings and structures now on said premises or hereafter placed thereon in good repair and in as good condition as they now are, complete all buildings or other structures being or about to be built thereon, and he will permit no waste upon the mortgaged premises.
- 7. He will continuously maintain hazard insurance, of such type or types and amounts as mortgagee may from time to time require, on the improvements now or hereafter on said premises, and except when payment for all such premiums has therefore been made under (a) of paragraph 2 hereof, he will pay promptly when due any premiums therefor. All insurance shall be carried in companies approved by the mortgagee and the policies and renewals thereof shall be held by the mortgagee and have attached thereto loss payable clauses in favor of and in form acceptable to the mortgagee. In event of loss mortgagor will give immediate notice by mail to the mortgagee, who may make proof of loss if not made promptly by mortgagor, and each insurance company concerned is hereby authorized and directed to make payment of such loss directly to the mortgagee instead of to the mortgagor and the mortgagee jointly, and the insurance proceeds, or any part thereof, may be applied by the mortgagee at its option either to the reduction of the indebtedness hereby secured or to the restoration or repair of the property damaged. In event of foreclosure of this mortgage, or other transfer of title to the mortgaged property in extinguishment of the indebtedness secured hereby, all right, title and interest of the mortgagor in and to any insurance policies then in force shall pass to the purchaser or grantee.
- 8. He will not execute or file of record any instrument which imposes a restriction upon the sale or occurancy of the property described herein on the basis of race, color or creed.
- 9. If he default in any of the covenants or agreements contained herein, or in said note, then the mortgagee may perform the same, and all expenditures made by the mortgagee in a doing shall draw interest at the rate provided for in the principal indebtedness, and shall be repayable by the mortgager to the mortgagee, and, together with interest and costs accruing thereon, shall be secured by this mortgage.
- 10. Upon the request of the mortgagee, the mortgager shall execute and deliver a supplemental note or notes for the sum or sums advanced by the mortgagee for the alteration, modernization, improvement, maintenance, or repair of said premises, for taxes or assessments against the same and for any other purpose authorized hereunder. Said note or notes "hall be secured hereby on a parity with and as fully as if the advance evidenced thereby were included in the note first described above. Said supplemental note or notes shall bear interest at the rate provided for in the principal indebtedness and shall be payable in approximately equal monthly payments for such period as may be agreed upon by the mortgagor and mortgagee. Failing to agree on the maturity, the whole of the sum or sums so ad anced shall be due and payable thirty (30) days after demand by the mortgagee. In no event shall the maturity extend beyond the ultimate maturity of the note first described above.
- 11. If there is a default, regardless of whether the mortgagee elects to forcelose this mortgage, the mortgagee may collect all rents which may become due on the above property, deduct therefrom any necessary operating expenses, and apply the remainder on the balance due on the mortgage.
- 12. The mortgagee may appear in and defend any action or proceeding purporting to affect the security hereof, and the mortgagor will pay all costs and expenses, including costs of evidence of title and attorney's fees in a reasonable sum in any such action, or proceeding in which the mortgagee may appear.
- 13. If the mortgagor shall well and truly pay, or cause to be paid, the promissory note secured hereby, with interest as it shall become due and payable, and shall make all other payments provided for herein and therein, and shall otherwise compinion that the conditions and covenants herein contained, then this indenture and the estate hereby granted shall be null and void; otherwise, to remain

in full force and virtue. If the interest on the aforementioned note, or the principal thereof, shall not be punctually paid when the same becomes due and parable, as is provided in said note, or in case of any other default under the terms of this mortgage, or if mortgagor be adjudicated bunkrupt or made defendant in a bankruptcy or receivership proceeding, then and in such case the indebtedness hereby secured shall, at the option of the mortgagee, become immediately due and payable, and proceedings may forthwith be had by the mostgagee for recovery of the same, either by suit on said note or by foreclosure on this mortgage, snything in said note or in this indenture contained to the contrary thereof notwiths and ing. In any decree of foreclosure of this mortgage, all costs, including a reasonable attorney's fee and cost of title search, shall be included in the judgment, and in case such foreclosure suit is settled before judgment is recorded therein, such costs shall nevertheless be paid.
