## REAL ESTATE MORTGAGE

All that portion of the Southwest Quarter (SWk) of Section 6, Township 1 North, Range 5 E. W. M., lying southerly of the Belle Genter Road designated as County Road No. 1004 EXCEPT that portion thereof lying easterly of the Marrin-Didier Road designated as County Road No. 1125;

ALSO: The North Half of the Northwest Quarter (Nº NWk) of Section 7, Township 1 North, Range 5 E. W. M., EXCEPT the south 882 feet thereof, and EKCEPT that portion thereof lying easterly if the Marrin-Didier Road designated as County Road No. 1125.

SUBJECT to: Eagements, restrictions and rights of way of records.

Together with all buildings and other improvements now or hereafter located thereon, all rights and interests appurtenant thereto (including rights in easements, agreements, water supply and drainage rights and shares or mumberships evidencing such rights), all property, equipment and appliances row or hereafter in any manner affixed or attached to such land or the buildings or improvements thereon for use in connection therewith, even though such liems may be removed for convenience, such as storm windows, wors, screens, awnings and like items (which shall for the purpose of this mortgage be deemed a part of said real property), and any interest therein which mortgager may hereafter acquire, together with all rents, issues and profits thereof—(all of which are herein referred to as "said property").

The desc secured by this mortgage is in the principal sum of \*THIRTY FIVE THOUSAND AND NO/100+ Dollars (\$35,000.00 ), payable in 240 monthly installments of Two Huntified Seventy One (.36/10/0) liers (\$271.36 ) each, all in accordance with the terms and conditions of one certain promissory note evidencing this debt, which note is of even date with this mortgage and is made, executed and delivered by the mortgage root the mortgage concurrently with this mortgage, and as a part of this contract.

Furthermore this martgage also secures any advances which the Mortgages may make to the Mortgages or their successors in title or interest, for any purpose at any time before the release and cancellation hereof, but at no time shall such advances together with the balance remaining due upon the original obligation exceed the sums first secured hereby, nor shall the term of this mortgage be increased, providing, however, that nothing in this paragraph contained shall be considered as limiting the amounth that may be secured hereby when advanced to protect Mortgagee's security or in accordance with other covenants contained herein.

The within described property is not used principally for agricultural or farming purposes.

THE MORTGAGOR HEREBY COVENANTS AND AGREES WITH THE MORTGAGEE THAT:

- I. He is the owner of the above described premise; that the same are now (lest of incumbrance; that he will keep the buildings and other destructible property covered by this mortgage insured ogainst loss by fire and other hazards in a sum at least equal to the mortgage's appraised value thereof; such insurance contract shall be issued by a respectible incurance company, and the policy evidencing the same shall be delivered into the possession of the mortgage. The said policy shall be endorsed by the mortgage and shall contain an appropriate clause providing that the less thereuner, if any, shall be dayable to the mortgage, in accordance with its interest at the time of less. Mortgage shall do all things necessary to obtain prompt. Buildenet for each and every loss or claim covered by any such policy. The mortgager further coverants that he will pay promptly all premiums on such insurance; and that he will pay promptly and before delinquency any and all installments of taxes, special assessments and other governmental levies which may hereafter be levied against or become a ten upon this mortgaged property; that he will keep the buildings and appurtenances on the said property and into the impaired during the life of this mortgage.

- III. In order to more fully protect the security of this mergage the mortgager, together with and in addition to the monthly installments of principal and interest payable under the terms of the note secured herety, on the first day of each month until the said note is fully paid, will pay to the mortgagee the forlowing sums:
- a. If, however, the monthly payments made by the mortgager under a of paragraph III preceding shall not be sufficient to pay ground rents, taxes assessments, or insurance premiums, as the case may be, when the same shall become due and pay ale, then the mortgager shall not be sufficiently on or before the date when payment of such ground rent, taxes, assessments or insurance premiums shall be due.
