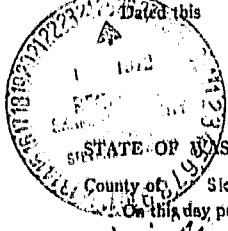
to secure payment of the sum of Two Thousand Nine Hundred Fifty and no/100ths - - -
