Section 325 of the Real Property Law expressly provides who must verify the authenticity of documents and also provides, among other things, that (1) no certificate shall pertain to documents more than one mortgage, except that mortgages affecting instruments of consolidation, surrender, modification or correction may be included in one certificate if the instrument is so set forth in detail in the certificate; (2) if the mortgage has been assigned, in whole or in part, the certificate shall set forth (a) the date of such assignment, in the chain of title of the person or persons owning the certificate, (b) the names of the assignor and assignee, (c) the interest assigned, including the instrument for which recorded, the book and page, where it has been recorded so as to make, and (d) if the mortgage has not been assigned of record, the certificate shall contain (i) the mortgage is held by any fiduciary, including an executor or administrator, the certificate of discharge shall recite the name of the court and the name of the proceedings in which his appointment was made or in which the estate of decedent, vesting him with such title or authority was entered.
