Partial Release of Mortgage (CORPORATE FORM)

KNOW ALL MEN BY THESE PRESENTS, That The National Bank Of Commerce Of Seattle, White Salmon Branch, a national banking association the owner and holder of that certain mortgage bearing date the 12th. day of December, 1966, executed by Harold E.
