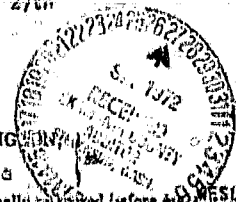

The North Half of the Southeast Quarter of the Northeast Quarter (N 1/2 SE 1/4 NE 1/4) of Section 1, Township 3 North, Range 7 1/2 E. W. M., EXCEPT that portion thereof lying northerly and easterly of the county road formerly designated as the Wind River Highway.
