## APPLICATION FOR UTILITY SERVICE

The undersigned, hereinafter called the Applicant, hereby applies for electric service and agrees to take such service from the Public Utility District No. 1 of Klickitat County, Washington, hereinafter called the District, upon the following terms and conditions:

- (1) The Applicant will pay to the District an Applicant's Service Deposit of \$ 15.00
- (2) The Applicant will pay an Applicant's Connection Fee of \$ -- This connection fee and interest at 6% per annum on the amount remaining unpaid shall be paid to the District in monthly installments of \$ (which include interest beginning within 10 days after the Applicant has been notified by the District that this application has been accepted)
- (3) The Applicant will, when service becomes available, purchase from the District such service used on the premises described below, and will pay therefor monthly at rates to be determined from time to time in accordance with the Consumer Service Policies established by the Board of Commissioners of the District provided, however, that the District may limit the amount of such service to be furnished for other than residential uses
- The Applicant will pay a bill of at least \$ 207.00 per month regardless of the amount of usage, for as long as the Code act is in force.
- (4) The Applicant will cause the installation of the necessary facilities on his premises for use of the service, to be in accordance with specifications approved by the District and in conformity with applicable codes and laws
- (5) The Applicant will comply with and be bound by such Consumer Service Policies as may be established by the Board of Commissioners from time to time
- (6) The Applicant, by paying a deposit fee, assumes no personal liability or responsibility for any debts or liabilities of the District

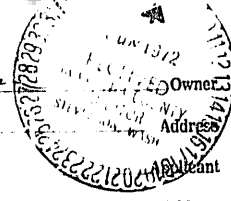
The acceptance of this Application by the District will constitute an agreement between the Applicant and the District, and the contract for service shall continue in force for 10 years from the date service is made available by the District to the Applicant, AND THEREAFTER FOR AS LONG AS SERVICE IS USED And until cancelled by at least 30 days written notice by either party.

HOUSE OR POINT OF SERVICE: located in subdivision of Section 2, Township 3 North, Range 10 E W M approximately miles from Skamania County, Washington

This contract and the obligations thereof shall run with and be binding upon the land of the undersigned in Skamania County, Washington described as follows: That part of Government Lot 3, Sec 2, T. 3N., R. 10E, W. 1M described as follows: Beginning at a point on the quarter section line south 02°08' east 450 feet from the north quarter corner of the said Sec 2; thence along said quarter section line south 02°08' east 207.28 feet to the southeasterly right of way line of Lakeside County Road; thence along said right of way line on a 105.39 foot radius curve right 91.1 feet (the chord of which bears south 44°30' west 67.94 feet); thence south 63°18' west 204.80 feet; thence on a 161.97 foot radius curve right 100 feet (the long chord of which bears south 70°48' west 99.71 feet); thence south 78°18' west 58.44 feet; thence on a 124.57 foot radius curve left 107.5 feet (the long chord of which bears south 53°39'30" west 103.66 feet); thence south 29°01' west 261.68 feet; thence on a 202.28 foot radius curve right 83.55 feet (the chord of which bears south 40°51' west 82.94 feet); thence south 31°15' east 139.26 feet to the south line of said Government Lot 3; thence along said south line south 89°20' west 377.34 feet; thence parallel with the north-south quarter section line of the said Section 2 north 02°08' west 1223 feet; thence north 88°57' east 300 feet; thence south 02°08' east 100 feet; thence north 88°57' east 520.32 feet; thence south 31°16'10" east 318.19 feet to the point of beginning. LESS right of way.
