

This lease, made and executed between Donald A. Brown, of North Bonneville, Washington, of the first part, and Mr. H. A. Greene, and or wife, ~~Connie~~ Connie Greene, of North Bonneville, Washington, of the second part.

WITNESSETH: That in consideration of the rents and other covenants hereinbefore expressed, the first party demises and leases and does hereby demise and lease to the second party the following described parcel of ground.

A plot of ground approximately seventy-five (75') feet east and west by seventy-five (75') feet North and South, known as Lots numbered Three (3), Four (4), and Five (5), in Block number Five (#5), situated in the Brown tract, a part of the old Chownith donation land claim, beginning at a point in the north line of State Road number eight (#8), three hundred and twenty (320') feet west of section line between Sections numbered twenty-one (21) and numbered twenty-two (22), township two (2), North Range seven (7) East, W. M. D., Clallam County, Washington.

The privilege thereto, for and during the term of ten (10) years from the 5th day of January 1967, to the 4th day of January 1977, with the further privilege of a ten year extension of time, which extension shall be granted at the second party's option.

The amount of rent to be paid upon the 1st day of every following month, reckoned by the day or days to be paid to Donald A. Brown with whom the rental of five (5) dollars during the term of this lease.

It is understood that the use of said ground by the second party is for the sole purpose of residence and/or living quarters, and they agree to keep the same in a clean, orderly condition, to comply with all sanitary laws and regulations intended by the community, and to the best of their ability to prevent damage from fire, explosion or intoxicating liquor.

It is agreed that the second party will pay taxes assessed against the ground value.


