## AGREEMENT

THIS AGREEMENT made this 20th day of July, 1975, by and between W.J. SEUFERT LAND COMPANY, INC., an Oregon corporation, WILLIAM DIELSCHNEIDER and EDRA-ANN DIELSCHNEIDER, hereinafter called the First Party and JOHN A. HOPE and SUSAN C. HOPE, hereinafter called the Second Party.

IT IS AGREED that the parties have reached accord in all respects and are willing to release one another from all further obligations except as may be found in the agreement for the purchase of timber and agreement for purchase of quarry rock as all executed this date.

As a material portion of this agreement of settlement and accord, Second Parties represent to First Parties that they have paid or will pay any and all taxes, assessments and contributions that pertain to the business maintained by them either in their own names or the name of Frog Lake Fish Company. Each party agrees that they are on it will not make any further commitment which will bind the other except as to the title to quarry rock.
