THIS INDENTURE, dated this 1st day of November, 1968, by and  
between DEAN O. EVANS and BETTY J. EVANS, Lessor, and UNION OIL  
COMPANY OF CALIFORNIA, a corporation, Lessee:

WHEREAS, Lessor leased to Lessee by that certain Service Station  
Site and Facilities Lease dated June 5, 1961, and short form of Lease  
thereof also dated June 6, 1961, and recorded December 26, 1961, in  
Book 4, Page 195, Official Records in the Office of the County Recorder  
of Skamania County, Washington, that certain real property in the County  
of Skamania, State of Washington, described as follows:

A 40 foot by 50 foot portion of building located on Lots Seven  
(7), Eight (8), Nine (9), and Ten (10), Block Six (6), Riverview  
Addition to the Town of Stevenson, Washington now utilized for  
service station business and North 18 feet of said Lots Seven  
(7), Eight (8), Nine (9), and Ten (10);  
together with the buildings and equipment now located or to be placed  
thereon by Lessor as described in Exhibit "A" attached to said Service  
Station Site and Facilities Lease; and

WHEREAS, pursuant to the terms and conditions of that certain  
Modification of Lease dated November 1, 1968, Lessor and Lessee have  
agreed to modify said Service Station Site and Facilities Lease and  
said short form lease in several respects including extending the term  
thereof.

NOW THEREFORE, in consideration of the premises and the covenants  
and conditions set forth in said Modification of Lease, it is agreed  
effective November 1, 1968:  
That the term set forth in said Service Station Site and

Facilities Lease and short form of Lease is extended to October 31, 1973  
subject to the terms and conditions set forth in said Service Station  
Site and Facilities Lease and said Modification of Lease.

Lessee of the within and foregoing modification shall not be considered delinquent in the payment of any rental to the undersigned unless and until said Lessee shall have received at least thirty (30) days' prior written notice of the date the undersigned acquired possession or right thereto of the demised premises.

This agreement shall be binding upon the heirs, assigns, transferees or successors in interest of the undersigned.


