

A G R E E M E N T

This AGREEMENT executed this date between DELLA B. MILLER, a widow, LEE D. MILLER and JOYCE M. MILLER, husband and wife, DAVID C. LIVOLSI and ENID A. LIVOLSI, husband and wife, NORBERT J. KIEDROWSKI and JOYCE E. KIEDROWSKI, husband and wife, LYLE W. CHAFFEE and WILMA J. CHAFFEE, husband and wife, and BARNEY M. SYVERSON and SHIRLEY M. SYVERSON, husband and wife,

W I T N E S S E T H :

WHEREAS, the parties herein have various interests either as owner, contract vendor, or purchaser of certain real property situated in Skamania County, State of Washington, the over-all description of which is as follows:

PARCEL I

The Northeast quarter and the Southeast quarter of Section 24, Township 3 North, Range 5 East of the Willamette Meridian.
SUBJECT TO easements, reservations and restrictions of record.

PARCEL II

Government Lots 1 and 2 and the East half of the Northwest quarter of Section 30, Township 3 North, Range 6 East of the Willamette Meridian.
SUBJECT TO easements, restrictions, and reservations of record, and

WHEREAS, said properties are variously affected by a 30-foot easement as set forth in instrument recorded in Book 50, at page 62; Book 57, at page 813; and Book 70, at page 625, records of Skamania County, Washington, and

WHEREAS, certain of the parties have constructed a bridge on said easement across the Washougal River for the benefit of all properties, and

WHEREAS, the parties desire to settle and clarify their respective rights and obligations concerning use and maintenance of the aforesaid bridge,

NOW THEREFORE, in consideration of the mutual agreements herein contained and in consideration of the contributions of the parties to the cost of construction of said bridge, it is agreed as follows:

1. That DAVID C. LIVOLSI and ENID A. LIVOLSI, husband and wife, shall be deemed to own a ten percent (10%) equity interest in said bridge and shall share in the repair and maintenance of said bridge to the extent of ten percent (10%) of the cost or expense of the same.
2. That NORBERT J. KIEDROWSKI and JOYCE E. KIEDROWSKI, husband and wife, LYLE W. CHAFFEE and WILMA J. CHAFFEE, husband and wife, and BARNEY M. SYVERSON and SHIRLEY M. SYVERSON, husband and wife, shall be deemed to have a ninety percent (90%) equity interest in said bridge and shall share in the repairs and maintenance of said bridge to the extent of ninety percent (90%) of the cost or expense of the same.
3. Each party acknowledges and affirms the right to use of the bridge and the easements upon which said bridge is situated as granted or reserved in the respective deeds or real estate contracts affecting said properties.
