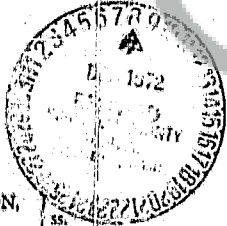
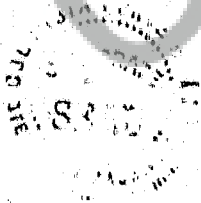
KNOW ALL MEN BY THESE PRESENTS, That **COLUMBIA GORGE BANK,** 75592

 hereby released.

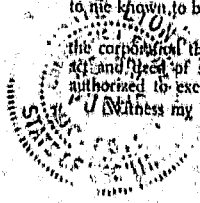
