beginning.

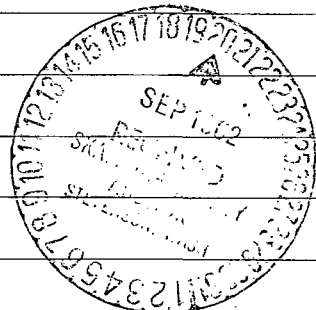
