

QUITCLAIM AND RELEASE

KNOW ALL MEN BY THESE PRESENTS, That WILLIAM J. WINEBERG, whose address is 11333 Southeast Evergreen Highway, Vancouver, Washington, GRANTOR, for a valuable consideration, does hereby remise, release, and forever quitclaim unto WEYERHAEUSER COMPANY, a Washington corporation, of P. O. Box 1645, Tacoma 1, Washington, GRANTEE, all right, title, and interest acquired under or by virtue of that certain Timber Deed dated June 8, 1960, in and to the following described lands situate in Skamania County, State of Washington:

PARCEL I.
