In any action to foreclose this mortgage or to collect any charge growing out of the debt hereby secured, or any suft which the mortgages may be obliged to defend to protect the unimpatited priority of the lien hereof, the mortgager agrees to pay a reasonable sum at attorney's fee and all costs and expenses in connection with such suit, and also reasonable cost of searching records, title company costs, which sums shall be secured hereby at "included in any decree of foreclosure.
