

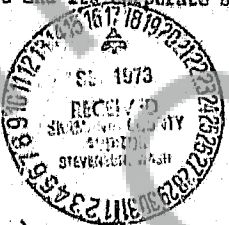
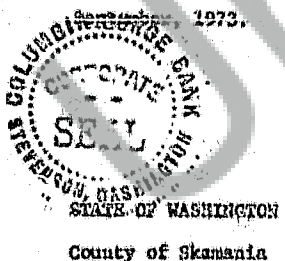
SATISFACTION OF MORTGAGES

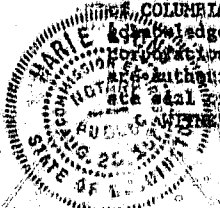
