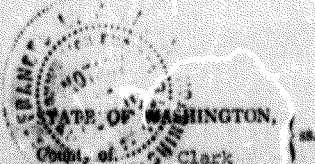

 to the initial point of the tract hereby described; thence north 48° 07' east 181 feet;
 thence north 41° 34' west 112.3 feet; thence north 08° 40' west 93.3 feet to the center
 line of Strawberry Road; thence following the center line of said Strawberry
 Road south 02° 21' west 22.1 feet to the intersection of said Strawberry Road with
 Frank Johns Road; thence south 41° 01' east 22.1 feet along the center line of the
 said Frank Johns Road; thence north 48° 07' east 46.7 feet to the initial point.
