
## TRANSMISSION LINE EASEMENT

The GRANTOR, herein so styled whether one or more, RAY M. RANDALL and DORIS M. RANDALL, husband and wife,

for and in consideration of the sum of -FIFTY
in hand paid by the UNITED STATES OF AMERICA, receipt of which is hereby acknowledged, hereby grants
bargains, sells, and conveys to the UNITED STATES OF AMERICA and its assigns, a perpetual easement and right
to enter and erect, maintain, repair, rebuild, operate, and patrol 1 or more line(s) of electric power transmission
structures and appurtenant signal lines, including the right to erect such poles, transmission structures, wires
cables, and appurtenances as are necessary thereto, in, over, upon, and across the following-described parcel o
land in the County of Skamania in the State of Washington towit:

That portion of Government Lot 3 of Section 36, Township 3 North, Range  $7\frac{1}{2}$  East, Willamette Meridian, Skamania County, Washington, which lies within a strip of land 87.5 feet in width, lying on the northerly side of, running parallel with, and adjoining the existing 300 foot right of way of the United States of America for its Bonneville Power Administration's Bonneville-Coulee transmission line, the location of said 300-foot right of way being shown in Judgment on Declaration of Taking entered in Docket No. 34 of the District Court of the United States for the Western District of Washington, Southern Division, a certified copy of said judgment being recorded on February 6, 1939, in Book 27, page 315, under Auditor's File No. 26971,



together with the present and future right to clear said right of way and keep the same clear of brush, timber, structures, and fire hazards, provided that fire hazards shall not be interpreted to include any growing crops other than trees.

TO HAVE AND TO HOLD said easement and rights unto the UNITED STATES OF AMERICA and its assigns, forever.

The Grantor covenants to and with the UNITED STATES OF AMERICA and its assigns that the title to all brush, timber or structures existing upon the right of way on January 28, 1963, shall vest in the UNITED STATES OF AMERICA on said date; and that the consideration stated herein is accepted by the Grantor as full compensation for all damages incidental to the exercise of the rights granted hereunder.

The Grantor also covenants to and with the UNITED STATES OF AMERICA that Grantor is lawfully seized and possessed of the lands aforesaid; has a good and lawful right and power to sell and convey same; that same are free and clear of encumbrances, except as above indicated; and that Grantor will forever warrant and defend the title to said easement and the quiet possession thereof against the lawful claims and demands of all persons whomsoever.
