Commencing at a point on the existing westerly right of way line of the Cooks-Underwood Road and the intersection of the east line of the Northwest quarter of the Northwest quarter of the Northwest quarter of Section 23, Township 3 North, Range 10 East, W.M., said point being 200.00 feet South of the northeast corner thereof; thence South 170.0 feet; thence South 30° 36' East 70.0 feet; thence South 59° 24' West 20.0 feet; thence South 30° 36' East 100.00 feet; thence North 59° 24' East 20.0 feet; thence South 30° 36' East 186.11 feet to P.T.
