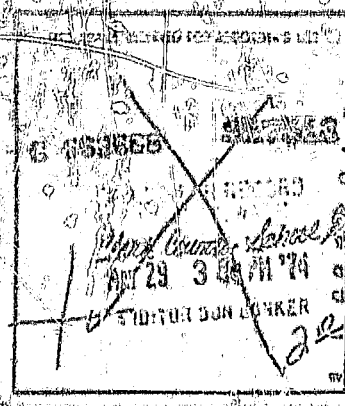

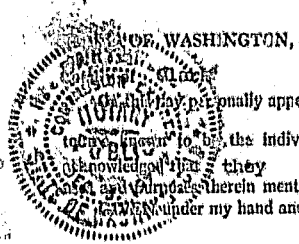
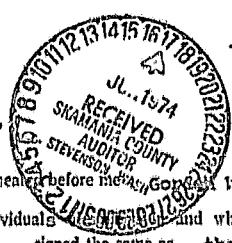
Beginning at the iron pin marking the center of Section 34, Township 2 North, Range 6 E. W. M.; thence north 00° 26' west along the west line of the SW1/4 of the NE1/4 of the said Section 34 a distance of 890 feet; thence north 89° 34' east 30 feet to the easterly right of way line of the county road known and designated as Woodard Creek Road (County Road No. 1014), said point being the initial point of the tract hereby described; thence north 89° 34' east 220 feet; thence north 00° 26' west 220 feet; thence south 89° 34' west 180 feet, more or less, to the easterly right of way line of said Woodard Creek Road; thence southerly following said right of way line to the initial point.

And the mortgagors promise and agree to pay before delinquency all taxes, special assessments and other public charges levied, assessed or charged against said described premises, and to keep all improvements on said described premises insured against loss or damage by fire in the sum of Six thousand thirty three and 04/100 Dollars, (\$ 6033.04) for the benefit of the mortgagee and to deliver all policies and renewals to the mortgagee
