We hereby mutually agree that all of the property which shall hereafter be acquired by either of us, whether separately, jointly or otherwise, and of whatsoever nature and wheresoever situate, shall be and it is hereby declared to be community property, and each of the parties does hereby convey and transfer to the other and to the community all such property hereafter acquired by either of them, even though the same be acquired in his or her separate estate, and

IT IS FURTHER AGREED that the whole of the community property now owned by us or hereafter acquired by us, including property the status of which is changed or created by this agreement, shall at once, in the event of the death of Arthur F. Mesford while the said Eunice B. Mesford survives, be vested in Eunice B. Mesford absolutely and in fee simple as her sole and separate property, and in the event of the death of Eunice B. Mesford while the said



Arthur F. Mesford survives, then the whole of the community property now owned by us or hereafter acquired by us, including all property the status of which is changed or created by this agreement, shall at once vest in the said Arthur F. Mesford absolutely and in fee simple as his sole and separate property.
