beginning on the 10th day of November , 19 74 , and payable on the 10th day of each month thereafter, according to the terms and conditions of one certain promissory note bearing even date herewith.

This mortgage lien shall continue in force and exist as security for any and all other advances which may hereafter be made by the Mortgage, of the Mortgager, and shall continue in force and exist as security for any debt now owing, or hereafter to become owing, by the Mortgage, to the Mortgage.

The Mortgagors hereby (fointly and severally if more than one) covenant and agree with the Mortgagee as follows:

That the Mertgagors have a valid, unincumbered title in fee simple to said premises, and will warrant and ferever defend the same against the lawful claims and demands of all person who insoever.

That the Mortgagors will during the continuance of this mortgage, permit no waste or stop of the mortgaged premises and will keep the buildings and appurtenances on said property in good state of repair.

That the Mortgagors will pay said promissory note according to its terms. Should the Mortgagors fall to pay any installment of principal or interest provided for in said note, or any sum due under this mortgage, or breach of any covenant or agreement herein contained, then the entire debt secured by this mortgage shall, at the election of the Mortgages, become immediately due and payable. Should the Mortgagors fail to pay any sum which they are required to pay, the Mortgagor may, without waiver of any remedy hereunder for such breach, make full or partial payment thereof, and the amount so paid with interest thereof at 10% per annum shall become immediately payable to the Mortgagor and shall be secured by this mortgage. Any payments made by the Mortgagors upon the indebtedness secured by this mortgage may be applied as the Mortgagore may elect either upon the amount which may be due upon said promissory note or upon any amount which may be due under the provisions of this mortgagor.

That the Mortgagors will keep all buildings thereon continuously insured against loss or damage by fire and such other hazards as the Mortgagee may specify to the extent of the amount due hereunder, in zone responsible insurance company or companies satisfactory to the Mortgagee and for the protection of the latter, and that the Mortgagees will cause all insurance policies to be suitably endorsed and delivered to the Mortgagee, together with receipts showing payment of all premiums due therefor, and that the Mortgages will leep no insurance on said building other than as stated herein. That it shall be optional with the Mortgagee to mane the company or companies and the agons: thereof by which the instrumes shall be written, and to refuse acceptance of any piley offered, and to surrender and cause to be cancelled any policy which may be received or accepted and to place the insurance or cause the policies to be written, all at the cost, charge and expense of the Mortgagors; but in no event shall the Mortgagee be held responsible for failure to have any insurance written or for any loss or damage growing out of a defect in any policy, or growing out of the fullility of any insurance written or for any loss or damage growing out of a defect in any policy, or growing out of the fullility of any insurance written or for any loss or damage frauered angainst. That the Mortgagee is authorized to compromise and settle any claims for insurance, and to receipt therefor on helaff both of the Mortgagors and their assigns and the Mortgagee.

That the Mortgagors will pay all taxes, assessments, and other governmental levies, now or hereafter assessed against the mortgaged premises, or imposed upon this mortgage or the note secured hereby, as soon as the same become due and payable, and shall immediately pay and dischange any lien having precadence over this mortgage, and to assure prompt payment the Mortgagors agree to pay to the Mortgagee monthly budget payments estimated by the Mortgagee to equal one-twelfth of the annual insurance premiums, taxes, assessments, and other governmental levies, which are or may become down upon the mortgaged premises, or upon this mortgage or the note secured hereby, the amount of such phyments to be adjusted from time to time as conditions may require. The budget payments so accumulated may be applied by the Mortgagee to the payment of such taxes, assessments, or levies, in the amounts shown by the official statements thereof, and to the payment of insurance premiums in the amount actually paid or incurred therefor. And such budget payments are hereby pledged to the Mortgagee as collateral security for full performance of this mortgage and the note secured hereby and the Mortgagee may, at any time, without notice, apply said budget payments upon any sums delinquent upon said that or under the terms of this mortgage.

In any action brought to foreclose this mortgage or to protect the lien hereof, the Mortgages shall be entitled to recover from the Mortgagers a reasonable attorney fee to be allowed by the court, and the reasonable ost of searching the records and obtaining abstracts of title or title reports for use in said action, and said sums shall be secured by this mortgage. In such fore-closure action a deliciency judgment may be entered in favor of the Mortgage, and a receiver may be appointed at the Mortgage's request to collect the rents, issues and profits from the mortgaged premises.

And it is further covenanted and agreed that the owner and holder of this mortgage and of the promissory note secured hereby shall have the right, without notice, to grant to any person liable for said mortgage indebtedness, any extension of time for payment of all or any part thereof, without in any way affecting the personal liability of any party obligated to pay such indebtedness.

Wherever the terms "mortgagots" occur herein it shall mean "mortgagor" when only one person executed this document, and the liability hereunder shall be plint and several.
