SUBJECT, however, to the following covenants:

1. This easement is for road right-of-way and for any purpose deemed necessary for access for forest protection, reforestation, development and utilization, (including logging), subject to the authority of the Supervisor of Department of Natural Resources to regulate the use thereof and the particular use indicated on said "Exhibit A".
2. Said road shall not be used for any other purposes than granted.
3. Nothing in the easement shall prevent the Grantor, or any person with its consent, from making use of said road across the above-described property for any purpose; PROVIDED, HOWEVER, that such use shall not interfere with, or restrict the Grantee's use, or create any undue maintenance cost by reason thereof.
4. Permission is hereby granted to permit such snags on the above-described land to be felled as may be directed by the Supervisor of the Department of Natural Resources for the purpose of establishing snag-free breaks, providing approval for all tree falling is first obtained from a representative of the Grantor and any merchantable timber felled shall be decked at the side of the road and remains the property of the Grantor.
