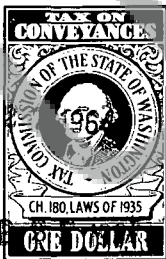
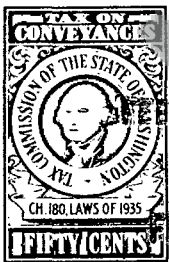
THE GRANTOR S AGATHA WILSON, who acquired title as Agatha Hodgkinson,
