ficial plat thereof;

EXCEPT that portion thereof acquired by the United States of America for  
the Bonneville Power Administration's electric power transmission lines  
and access roads thereto;

AND SUBJECT TO transmission line easement granted to the United States of  
America by deed dated June 19, 1963.

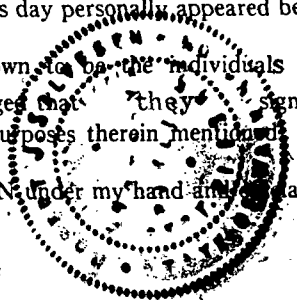
