

does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs and assigns, that  
certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the State of OREGON and the county therein named below, described as follows, to-wit:

That portion of the Southeast quarter of the Southeast quarter (SE $\frac{1}{4}$  SE $\frac{1}{4}$ ) of  
Section 24, Township 3 North, Range 7 E. W.M., Skamania County, Washington, described  
as follows: Beginning at a point 144.2 feet north and 232.7 feet west of the southeast  
corner of said section 24, said point being located on the center line of the county road  
known and designated as the Loop Road; thence North 08° 04' West 406.82 feet; thence west  
421.92 feet to the initial point of the tract hereby described; thence west to intersection  
with the west line of the SE $\frac{1}{4}$  of the SE $\frac{1}{4}$  of said Section 24; thence south 547 feet, more or  
less, to the southwest corner of the SE $\frac{1}{4}$  of the SE $\frac{1}{4}$  of said Section 24; thence east follow-  
ing the south line of said Section 24 to a point due south of the initial point; thence  
north 547 feet, more or less, to the initial point.

And said grantor hereby covenants to and with said grantee and grantee's heirs and assigns, that  
grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances

grantor's heirs, executors and administrators shall warrant and forever defend the above granted premises  
and every part and parcel thereof against the lawful claims and demands of all persons whomsoever.
