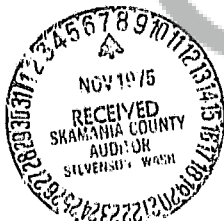
Partial Release of Mortgage

Beginning at a point on the southerly line of the Evergreen Highway which is south 1,257 feet and west 23.93 feet from the common corner of Section 15, 16, 21 and 22, Township 2 North, Range 7 N. W. M.; thence north 81° 00' west along said highway 850 feet; thence north 79° 51' west along said highway 350 feet to the initial point of the tract hereby described; thence north 79° 51' west along said highway 50 feet; thence south 10° 09' west 100 feet; thence south 79° 51' east 50 feet; thence north 10° 09' east 100 feet to the initial point; said tract being design'd as Lot 16 of Block Four of the unrecorded plat of North Bonneville, Skamania County, Washington.
