## Partial Release of Mortgage

A tract of land located in the South One-half of the Northwest One-Quarter (S½ NW¼) of Section 23, Township 3 North, Range 8 E.W.M., more particularly described as follows: That portion of the N 350 ft. of the S½ of the NW¼ of Section 23, T3N, R8 E.W.M. lying easterly of the county road known and designated Berge Road (Co. Rd No. 3036), containing 6½ acres, more or less. TOGETHER with an easement over and across the grantors' property for a water transmission line from grantors' existing water system to the grantees' property line, sufficient to lay a 2" water line along with the right to maintain the same; AND, TOGETHER with the right to the use of water from grantors' existing water system for domestic purposes. SUBJECT to easements and rights of way for county roads thereon.

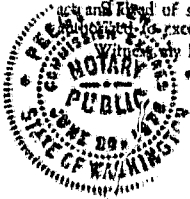
