CERTIFICATE OF ABANDONMENT

Under date of June 28, 1948, Walter Rhodes and Maemye Rhodes, his wife, Howard Mostert and Mary Mostert, his wife, executed an easement in favor of the United States, acting by and through the Forest Service, which said easement was filed for record August 19, 1948, and recorded in Book 32 of deeds at page 130 of the Records of Skamania County, Washington.

Under date of June 11, 1953, these same persons executed an easement in favor of the United States, acting by and through the Forest Service, for the purpose of correcting the description contained in the first mentioned easement. The latter easement was filed for record on August 14, 1953, and recorded in Book 37 of deeds at page 104 of the Records of Skamania County, Washington.

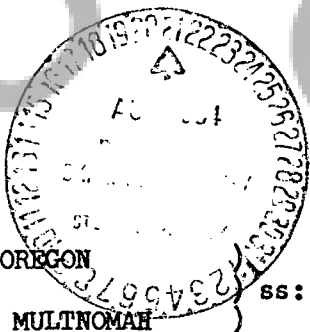
The easements mentioned were donations.

A road was constructed over the above mentioned easement. This road is no longer used by the Forest Service and there is no foreseeable future need for said road or easement.

It has been deemed that the said road and easement has no commercial value.

Under the circumstances it would seem to be an unjustifiable burden to retain said road and easement on inventory and said road and easement are therefore deemed abandoned by the Forest Service.

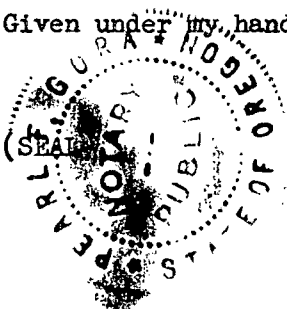

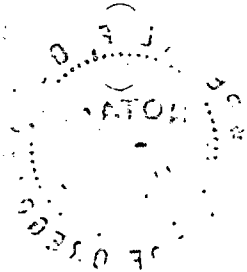
