And such budget payments are hereby pledged to the Mortgagee as collateral recurity for full performance of this mortgage and the note secured hereby and the Mortgagee may, at any time, without notice, apply said budget payments upon any sums delinquent upon said note or under the terms of this mortgage.

In any action brought to forceless this mortgage or to protect the lien hereof, the Mortgages shall be entitled to recover from the Mortgages a reasonable attorney fee to be allowed by the court, and the reasonable cost of searching the records and obtaining abstracts of title or title rejects for use in said action, and said sums shall be secured by this mortgage. In such foreclosure action a deficiency judgment may be entered in favor of the Mortgage, and a receiver may be appointed at the Mortgage's request to collect the rents, issues and profits from the mortgaged premises.
