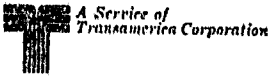

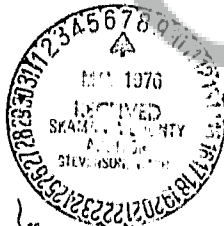
Satisfaction of Mortgage (CORPORATE FORM)

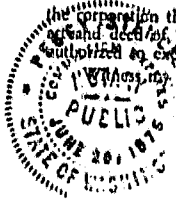
