KNOW ALL MEN BY THESE PRESENTS, that the undersigned, hereinafter referred to as Grantor, for and in consideration of ONE DOLLAR and other considerations, to Grantor paid by EL PASO NATURAL GAS COMPANY, a corporation, hereinafter called Grantee, the receipt of which is hereby acknowledged, does hereby grant, sell and convey unto said Grantee, its successors and assigns, a right of way 20 feet in width on which to construct, maintain and use a roadway over and across the following described lands in Skamania County, Washington, approximately along the line designated by survey heretofore made or hereafter to be made by the Grantee, through and over the said property:

The portion of the South 430 feet of Lot 9, Section 16, Township 2 North, Range 7 East, W.M., lying east of the natural gas pipe line constructed by Pacific Northwest Pipeline Corporation and west of Greenleaf Creek.

Also that portion of the B. B. Bishop D.L.C. in Section 16, Township 2 North, Range 7 East, W. M., lying north of Moffetts-Carpenter Road and westerly of the centerline of the right of way granted to the Northwestern Electric Company.

The rights herein granted are subject to outstanding easements of record in said County.

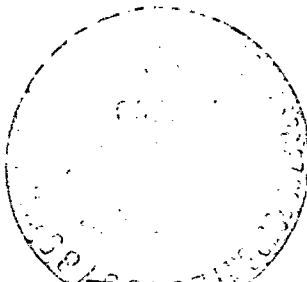
