TOGETHER WITH all the tenements, hereditaments, and appurtenances now or hereafter thereunto belonging or in anywise appertaining, and the rents, issues and profits thereof; and all fixtures now or hereafter attached to or used in connection with the premises herein described; and in addition thereto the following described household appliances, which are and shall be dremed to be, fixtures and a part of the realty, and are a portion of the security for the indebtedness herein mentioned:

THIS DEED IS FOR THE PURPOSE OF SECURING PERFORMANCE of each agreement of Grantor herein contained and payment of the sum of THENTY FIVE THOUSAND FIVE HUNDRED AND NO/100 Dollars is 23,500.00 ) with interest thereon according to the terms of a promissory note of even date her with, payable to the order of Beneficiary and made by Grantor, and also such further sums as may be advanced or loaned by Beneficiary to Grantor, or any of their successors or assigns, together with interest thereon at such rate as shall be agreed upon.

The Grantor covenants and agrees as follows:

- 1. That he will pay the indebtedness, as hereinbefore provided, Privilege is reserved to prepay at any time, without premium or fee, the entire indebtedness or any part thereof not less than the amount of one installment, or one hundred dollars (\$100,00), whichever is less, Prepay m at it full shall be credited on the date received. Partial prepayment, other than on an installment due date, need not be credited until the next following installment due date or thirty days after such prepayment, whichever is earlie.
