ing to the official plat thereof on file and of record in the office of the  
Auditor of Skamania County, Washington, more particularly described as fol-  
lows:

Beginning at the intersection of the north line of the said Lot 5 with the

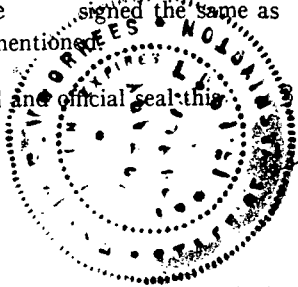
